Disability Can Happen

A disability can happen in many ways and occurs more often than you may realize.

Sickness:

***Cancer** - Lifetime chance of developing cancer is slightly less than 1 in 2 for men; a little more than 1 in 3 for women. 1

***Heart Attack** - About every 34 seconds, an American will suffer a heart attack. 2

***Stroke** - Stroke is the leading cause of serious long-term disability in the United States. 3

Accident:

***Home** - 51% of injuries occur at home. 4

***Work** - 12.5% of injuries occur at work. 4

***Car** - 8.2% of injuries occur in motor vehicles. 4
